1. Summary of the Arth-Ganga project:

The conceptualization of JMVP-II (Arth Ganga) was finalized to energize economic activities that will impact the overall ecosystem along the riverbank. Inland waterways are one of the most important pillars of JMVP-II (Arth Ganga). They can lead to inclusive growth and play a key role in improving the livelihoods of the populations.

JMVP-II (Arth Ganga) is being developed on an approach based on principles of a sustainable development model that focuses on economic activities in & around the hinterland of river Ganga by providing opportunities to local communities to transport their goods/produce and passenger & tourist movements through waterways as well as skill development and public/private sector capability developments to support the following:

- A. Economic benefits to the farmers, traders and public living around the Ganga belt;
- B. Growth of small-scale industries:
- C. Employment opportunities;
- D. Easy, cost-effective and environment-friendly transportation of cargo;
- E. Improved logistics through small jetties and
- F. Wider choice of logistics mode for cargo movement

Efficient logistics and transport systems are critical for sustaining and accelerating economic growth along the River Ganga. In this regard, JMVP has the potential to channel significant economic activities along the River Ganga, thus also aligning with the objective of JMVP-II (Arth Ganga).



2. Goals and Objectives:

Goals:

Arth Ganga is an initiative added recently to the Namami Ganga Program launched by the Government in 2014. It was decided in the meeting of National Ganga Council (NGC) held on 14th December 2019 to launch a new concept as the name Arth Ganga, which is a sustainable and viable economic development model to strengthen the river-people connect through an economic bridge. Accordingly, it was decided that the Namami Gange mission should lead the concept of Arth Ganga with the involvement of different ministries/departments and other stakeholders, institution & community organization. So it was added as a vertical of Namami Ganga Program, in addition to the 4 verticals – Nirmal Ganga, Aviral Ganga, Jan Ganga and Gvan Ganga.

Inland Waterway Authority of India (IWAI), Ministry of Shipping, Govt. of India is the implementing agency for the project: As a part of the project IWAI has established 60 community jetties in four states namely, Uttar Pradesh, Bihar, Jharkhand and West Bengal. A list of the Jetty sites is enclosed as Annexure-I

Objectives of the RFP:

It will contribute to a deeper understanding of how such projects influence community dynamics.
- ➤ To develop the software for capturing the Realtime footfall data of cross ferry waterway transportation day to day across the locations where community jetties are established.
- The project seeks to produce a Coffee table book & documentary that explores the significant impacts of the Community jetties on the lives of the local community. This video documentary will feature testimonials from residents and stakeholders who have experienced notable improvements following the installation of the jetties. It will effectively illustrate the functional advantages these structures offer over prior conditions, emphasising enhancements in accessibility, the creation of economic opportunities, and the fostering of social interactions that have strengthened community ties. By carefully capturing these elements, the Coffee Table book and documentary aims to comprehensively understand the jetties' crucial role in enhancing community life.

By capturing these insights and strategies, the model can be a valuable resource for other locations facing similar infrastructure challenges, promoting an adaptable framework for success.
